## DETAILS OF CUMULATIVE DISTRIBUTION IN CONNECTION WITH THE RECENT EQUITY FUND RAISING

Further to its announcement dated 21 September 2010 on the Cumulative Distribution Books Closure Date in connection with the equity fund raising ("Equity Fund Raising") which comprised a private placement of 207,310,000 new units and a pro-rata and non-renounceable preferential offering of 164,345,224 new units in Mapletree Logistics Trust ("MapletreeLog"), Mapletree Logistics Trust Management Ltd., in its capacity as the Manager of MapletreeLog (the "Manager"), is pleased to announce that the actual amount of the Cumulative Distribution for the period from 1 July 2010 to 14 October 2010 is 1.78 cents per unit. The next distribution will be for the period from 15 October 2010 to 31 December 2010. Quarterly distributions will resume thereafter.
